For spray application please ask for our special advice or request the equipment planner "Airless". Application must not proceed during rain, high humidity, frost or risk of frost. Freshly applied layers must be protected from dew, rain and frost.</li> <li>Standard systems: MC-Color Flair pro is generally applied in two layers. MC-Color Flair pro may be used in combination with Emcephob WM, Emcephob HC, Nafufill KM 103, Nafufill KM 110, Nafufill KM 220, Nafufill KM 110 HS and Nafufill DSP.</li> </ul>
	<ul> <li>Special system: On all other substrates priming with MC-Color Primer is necessary prior to application. Afterwards MC-Color Flair pro is applied in two layers.</li> <li>General information: Coverage rates depend on condition of the substrate which may lead to over- or under-consumption. Please observe the surface roughness surcharges indicated in the Application Advice. The colouring effect on the object depends on a number of factors, e.g. light, perspective, distance, surrounding and substrate conditions (smooth/rough, absorbent/impervious). The colouring effect is thus often a matter of subjective judgement. We therefore recommend applying a trial area with the chosen system. 	Depending on the chosen colour, e.g. bright yellow or bright red shades, there might be differences in the opacity and it may therefore be necessary to apply three top coats of MC-Color Flair pro.
