	<b>Priming:</b> Mineral-based substrates are primed with MC-DUR VS transparent, applied with roller. For slip- form and climbing form construction, MC-DUR 1277 WV (see technical data sheet) may also be used for priming.	
	<b>Application:</b> MC-DUR VS (see data sheet "MC-DUR VS)" is usually applied in two layers with roller, brush or airless spraying. In areas which require a high optical quality non-yellowing MC-DUR VS-PUR should be applied in the second work step.
